

**SAFARI CLUB INTERNATIONAL FOUNDATION KENTUCKY WHITETAIL DEER HUNT SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR DONATION NECESSARY TO ENTER. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING

Eligibility. Employees of SCI, SCIF, individuals or entities involved in the implementation or execution of this Sweepstakes, and members of their immediate family or household are not eligible. Void in Washington, Quebec, Canada and where prohibited, taxed, or restricted. This Sweepstakes is conducted in the United States and is governed by applicable US law.

How to Enter. This Sweepstakes begins on or about March 17, 2021 and ends at 11:59 p.m. Pacific Time on May 31, 2021 ("Sweepstakes Period"). There are five (5) ways to enter: (1) Go to www.safariclubfoundation.org and fill out an Official Sweepstakes Entry Ticket Form and follow all instructions to make a suggested donation to SCIF of \$20 (USD). (2) Call Kimberly Byers during normal business hours at SCIF at (520) 798-4891 with a valid credit card, to make a suggested donation to SCIF of \$20 (USD); (3) Receive one (1) entry for every \$25 donated to SCI Foundation as part of the Forever for Wildlife Monthly Giving Program (must be actively donating during the month the prize is drawn), (4) Receive two (2) free entries for submitting a completed and signed Planned Giving Intent Form to SCI Foundation, or (5) To obtain one (1) free entry ticket, complete a 3 x 5 card hand-printed in red ink and must include: name, address, age and daytime phone number, and a color copy of their state issued hunting/fishing license and mail it in a postage prepaid envelope addressed to Safari Club International Foundation, Kentucky Whitetail Deer Hunt Sweepstakes Entry, 4800 W. Gates Pass Road, Tucson, AZ 85745 (must be postmarked by May 24, 2021 and received by May 31, 2021, limit one entry per outer mailing envelope). Limit fifty (50) entries per person regardless of the method of entry. Multiple entries per person/email address in excess of the entry limit, or any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to sweepstakes entry services) are prohibited and will void all entries by that entrant. Participation is limited to the first 4,000 entries received. All entries, regardless of method, must be received by SCIF by 11:59 pm May 31, 2021 ("Entry Deadline"). Entrant assumes risk of loss, damage, destruction, delay and misdirection of entries, and is solely responsible for postage due, illegible or incomplete entries. Once submitted, entries become the sole property of SCIF and will not be returned. By entering, you agree to be bound by these official rules and the decisions of Sponsor which are final and binding in all respects.

Drawing. One winner will be selected in a random drawing conducted by Sponsor (or its authorized representative) immediately after the Entry Deadline on June 2, 2021 from all entries received. You do not need to be present to win. If a Canadian resident is selected in the drawing, he/she must correctly answer a skill-testing question in order to claim the prize. The question will be administered upon notification to the Canadian resident that he/she was selected. To receive the prize, the question must be correctly answered without assistance of any kind, within a specified time limit. Odds of winning a prize depend on the number of eligible entries received.

Prize/Odds of Winning. Prize (1): 5-Day Kentucky Whitetail Deer Hunt for Two (2) Hunters. Outfitter's Suggested Retail Price (MSRP): \$6,360. Winner must comply with all applicable local, state, federal and provincial regulations. Hunt prize will not be awarded in any state or province where such prize is prohibited by law. If winner resides in any such state or province, prize will be forfeited and an alternate winner will be selected. Odds of winning depend upon the number of eligible entries received, but are

no worse than 1:4000. No cash/prize substitutions, except SCI Foundation reserves the right to substitute a prize of comparable value in the event of prize unavailability.

Conditions of Participation. Winner will be notified by email, mail or telephone (at Sponsor's discretion) and will be required to sign and return an Affidavit or Declaration of Eligibility and Liability/Publicity Release and any other documentation reasonably required by SCI/SCIF within 14 days of notification. In the event of noncompliance, if winner cannot be reached, or prize notification is returned as unclaimed or undeliverable, the winner may be disqualified, and an alternate winner selected.
